The Passport Service 2020

The Passport Service paused operations on 27 March 2020 in response to the COVID-19 public health emergency. The Passport Service commenced a phased return to full operation on 8 June, clearing the outstanding applications in 4 weeks.


The Passport Service paused processing of routine passport and FBR applications when Ireland entered Level 5 of the National Framework for Living with COVID-19 on **21 October**. In line with the Government's Plan for Living with COVID-19 and the move to Level 3, the Passport Service began a phased return to full operations on **1 December**, clearing the outstanding applications within 3 weeks.

The Passport Service focussed on providing an emergency and urgent service when full operations were paused. We continued to provide a same day **emergency service** for the issuance of passports in cases of serious illness or death abroad. We also provide a weekly urgent service for adult renewals in Ireland and for citizens who contacted us from overseas.

As part of the response to the crisis, personnel from the Passport Service were **redeployed** into other essential public service roles, such as assisting the HSE with contact tracing and facilitating the payment of social welfare benefits for the Department of Social Protection.


Passport Applications Received and Passports Issued

Card Applications Received and Cards Issued


Passport Cards Issued (up to 6th December 2020)




Most Popular Baby Names in 2020



Due to the effects of COVID-19, the trends in 2020 indicate:


- A 55% decrease in applications made in Ireland in 2020 when compared with 2019.

- A 44% decrease in applications from Great Britain.
- A 31% decrease in applications from the rest of the world.



Born in Northern Ireland or Great Britain Applications


Trend of first time adults born in Northern Ireland or Great Britain Applications since 2015





Foreign Birth Registration Applications from Great Britain in 2020





The Total Number of Contacts with the Public via Phone and WebChat


Total Contacts per Month


