Diplomatic and Consular Fees (Amendment) Regulations 2019

I, SIMON COVENEY, Minister for Foreign Affairs and Trade, in exercise of the powers conferred on me by section 3 (amended by section 28 of the Passports Act 2008 (No. 4 of 2008)) of the Diplomatic and Consular Officers (Provision of Services) Act 1993 (No. 33 of 1993), (as adapted by the Foreign Affairs (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 246 of 2011)), with the consent of the Minister for Public Expenditure and Reform, hereby make the following regulations:

1. These Regulations may be cited as the Diplomatic and Consular Fees (Amendment) Regulations 2019.

2. The Diplomatic and Consular Fees Regulations 2013 (S.I. No. 46 of 2013) (amended by the Diplomatic and Consular Fees (Amendment) Regulations 2017 (S.I. No. 130 of 2017)) are amended by the substitution of the text set out in the Schedule for Part 1 of Schedule 2 to those Regulations.

22	For the processing of a passport or a passport card by the relevant Passport Office during normal hours of opening, on the same working day on which the application was received, in addition to the appropriate fee specified at Reference Numbers 1, 2, 3 or 4.	€150
23	For processing of a passport or a passport card within 5 working days of receipt of an application through the Passport Service on-line enrolment option in addition to the appropriate fee specified at Reference Numbers 13, 14, 15, 16, 17, 18, 19 or 20.	€40
