•	Within the time frame specified by the Immigration Officer at the port of entry, holders of Working Holiday Authorisations must register with the Garda National Immigration Bureau and will be issued with a Certificate of Registration on payment of the appropriate fee;					
•	Working Holiday Authorisations are issued on an individual basis. Holders of Working Holiday Authorisations shall not seek to be accompanied or joined by a spouse or dependents;					
•	Permission granted to those entering Ireland on the basis of a Working Holiday Authorisation shall be valid for a maximum period of twelve (12) months from the date of entry into Ireland. Extensions to the period of validity of such permission shall not be granted. Participants must leave Ireland on the expiration of the permission, which cannot be extended, either under the authorisation itself, or through attempting to convert it to a different form of immigration status;					
•	Argentine nationals who are already in Ireland with an immigration status other than that based on a Working Holiday Authorisation may not convert to permission based on a Working Holiday Authorisation without leaving the State and re-entering on the basis of the valid Working Holiday Authorisation.

DOCUMENTATION REQUIRED

This fully completed and signed application form should sent by post or by recorded post/ courier to the Embassy of Ireland in Buenos Aires together with 2 recent identical passport photographs and photocopies of:

Stage 1:

- Valid Argentine passport (a photocopy of the photograph page only is required at the application stage);
- Current curriculum vitae (no longer than 2 pages & including contact details for referees);
- An up-to-date bank statement showing that you have access to the equivalent of €1,500 Euros;
- Certificate of highest qualification attained. If you are still attending, or are awaiting results from school/college/university, a letter from that institution should be presented;
- A police certificate of good conduct (Certificado de Antecedentes Penales).

Stage 2:

If the Embassy is satisfied with the documentation above and there are places remaining on the programme, the application will be approved in principle and the applicant notified. Payment of the corresponding fee to be timely decided should be made and proof of payment provided to Embassy only when all of the original documents required have been prepared.

The Working Holiday Authorisation will be issued on submission of the originals of the documents above along with:

- Return airline tickets;
- Certificate of medical insurance valid for the duration of the trip (based on dates on tickets);
- Valid Argentine passport that is valid for the entirety of the trip to Ireland i.e. for a full year after ticketed date of entry.
- Proof of payment
