- Within one month of arrival in Ireland, holders of Working Holiday Authorisations must register with the Garda Nation Immigration Bureau and will be issued with a Certificate of Registration on payment of the appropriate fee; the current fee is €300 (this is subject to change).
- The Working Holiday Authorisations are issued on an individual basis. Holders of the Working Holiday Authorisation shall not seek to be accompanied or joined by a spouse or dependents.
- Permission granted to those entering Ireland on the basis of a Working Holiday Authorisation shall be valid for a maximum period of twenty four (24) months from the date of entry into Ireland.
- Extensions to the period of validity of such permission shall not be granted.

  Participants must leave Ireland on the expiration of the permission, which cannot be extended nor renewed.
