24871062	Refused	ID:- Insufficient information was submitted by the applicant in support of the application:- It is noted that applicant was interviewed by Local staff here who conducted the interview in the Hindi language. Applicant appeared to have very little knowledge of who he would be working for, where his job was, and the preparation of any basic Tandoori Dishes that an alleged Tandoori Chef should be easily familiar with. It is noted that the Department of Jobs do not interview applicants for Employment Permits, nor do they seek to verify qualifications or work experience of prospective applicants, merely relying on a declaration of suitability signed by the employer and employee. This alone is not sufficient to satisfy the requirement as to why somebody should be granted an Employment Visa. It has not been demonstrated that failure to grant this visa would represent an economic loss to Ireland in this case.
