VA15030272: applied to travel to Ireland from 29/12/13 - 05/01/14. You claim you travelled by ferry and coach on the dates 04/02/14 - 10/12/14. When you were queried by a Visa Officer in 2014 about why there were no immigration stamps on your passport you stated you took the boat "to buy a car in Ireland". VA18257952: applied to travel to Ireland from 04/10/14 - 10/10/14. Instead you have confirmed you left the UK on 28/09/14 to travel to Pakistan and returned via Ireland on 06/11/14. You therefore again did not adhere to the travel plans as stated to this office nor did you inform this office of your change of plans.
