UPDATE ON VISA REQUIREMENTS FOR MALAWI

The Malawi Immigration Department would like to inform those intending to travel to Malawi, the Airlines, and all Stakeholders that with effect from 9th September, 2016 Entry Visa issuance will be implemented in **three-fold** as approved by the Malawi Government.

NOTE:

- Visa arrangements in Malawi are on a **reciprocal** basis as such the list is subject to change from time to time.
- Visa fees are payable in **United States Dollars (USD) (\$)**.
- Visa in Malawi only means **permission to enter** the country. The visitor is then given a maximum of 30 days **Visitor's Permit** on the port of entry which can be extended up to a maximum of 90 days. Therefore please take note that a visa is just an **authority to enter**, whereas the visitors permit determines the **visitor's duration of stay**.
