 for presentation at an Irish port of entry within twelve months of the date of
 issue; 워킹 홀리데이 승인서를 소지한 대한민국 국민으로 발급일로부터 12 개월 이내에
 아일랜드 입국 하여야 하며 입국 시 승인서를 이민 심사관에게 제시합니다;
- Within one month of arrival in Ireland, holders of Working Holiday
 Authorisations must register with the Garda National Immigration Bureau and
 will be issued with a Certificate of Registration on payment of the appropriate
 fee; 워킹 홀리데이 승인서 소지자는 아일랜드 입국 후 1 개월 이내에 아일랜드 국립경찰청
 산하 이민국(the Garda National Immigration Bureau)에 수수료와 함께 거주 허가 등록을
 신청하여 등록증을 발급 받습니다;
- Working Holiday Authorisations are issued on an individual basis. Holders of Working Holiday Authorisations shall not seek to be accompanied or joined by a spouse or dependents; 워킹 홀리데이 승인서는 선발된 신청자에게만 개별적으로 발급되며

승인서 소지자는 배우자 또는 부양가족을 동반하지 않습니다;

- Permission granted to those entering Ireland on the basis of a Working Holiday Authorisation shall be valid for a maximum period of twelve (12) months from the date of entry into Ireland. Extensions to the period of validity of such permission shall not be granted. Participants must leave Ireland on the expiration of the permission, which cannot be extended, either under the authorisation itself, or through attempting to convert it to a different form of immigration status; 워킹 홀리데이 승인서로 아일랜드 입국 허가를 받은 경우 체류기간은 입국일로부터 최장 12 개월 입니다. 체류기간 연장은 허용되지 않습니다. 워킹 홀리데이 참가자(승인서 소지자)는 12 개월 체류기간 만료 시 반드시 아일랜드를 떠나야 하며 어떠한 이유로도 워킹 홀리데이 기간을 연장하거나 다른 체류 목적으로 갱신 하지 않습니다;
- Nationals of the Republic of Korea who are already in Ireland with an immigration status other than that based on a Working Holiday Authorisation may not convert to permission based on a Working Holiday Authorisation without leaving the State and re-entering on the basis of the valid Working Holiday Authorisation; 워킹 홀리데이가 아닌 다른 목적으로 아일랜드에 이미 체류 중인 대한민국 국민은 아일랜드 체류 기간 중에는 워킹 홀리데이로 전환 할 수 없으며 위킹 홀리데이 신청을 위해선 출국하여 승인서를 발급 받은 후 재 입국하여야 합니다;
