One of those is that both parties must be over the age of 18. In this case, Ms Aydiya Bouterfas was 17 years old at the time of marriage.

As outlined in section 15.1 of the Policy Document on Non-EEA Family Reunification the eligibility requirement for spouse is as follows:

“The spouse, civil partner or de facto partner must be at least 18 years of age at the time of their application for family reunification. Consideration was given to adopting a higher minimum age of 21 years as a means of discouraging forced marriages or unions where the youth of one party rendered them vulnerable. However, it has been decided for the present to retain the current position whereby the age threshold for spousal family reunification is the same as applies in respect of eligibility to marry within the State. While it is possible in many jurisdictions to marry at a younger age and a court dispensation may in certain circumstances be obtained within this State to set aside the age limit for one or both parties, it is not intended to follow this through in terms of family reunification. The 18 year limit will be maintained.”

As Ms. Aydiya Bouterfas is ordinarily resident in the State, the minimum age at which she may marry is 18 years (unless she had a Court Exemption Order). This is the case for all citizens of the State even if they choose to marry outside of Ireland. Section 31(1) of the Family Law Act 1995 (revised to 18 January 2016) states as follows:

31.—(1)(a) (i) A marriage solemnised, after the commencement of this section, between persons either of whom is under the age of 18 years shall not be valid in law.

(ii) Subparagraph (i) applies to any marriage solemnised—

(I) in the State, irrespective of where the spouses or either of them are or is ordinarily resident, or

(II) outside the State, if at the time of the solemnisation of the marriage, the spouses or either of them are or is ordinarily resident in the State.

(b) Paragraph (a) does not apply if exemption from it was granted under section 33 before the marriage concerned.

(c) The requirement in relation to marriage arising by virtue of paragraph (a) is hereby declared to be a substantive requirement for marriage.

As a result of the Family Law Act, 1995 and having due regard to the eligibility criteria as set out in section 15.1 of the Policy Document on Non-EEA Family Reunification, we are refusing this application.
