It is stated that the applicant is involved with a family company - no evidence of this is supplied. It would appear that the applicant has two passports, one of which she is currently travelling in the UAE on. Only partial pages from this passport were provided. As per INIS website, all pages of previous and current passports should be provided.</p> <p>INCO:- Inconsistencies e.g. contradictions in the information supplied. Briefing note and fund presentation supporting documentation provided however, none of this information is visible on the website of the Irish company, which is basic in terms of content.</p> <p>OB:- Obligations to return to home country have not been deemed sufficient.</p> <p>OC:- Observe the conditions of the visa - the visa sought is for a specific purpose and duration:- the applicant has not satisfied the visa officer that such conditions would be observed.</p> <p>R:- No clear link to reference has been shown - no previous history demonstrated between the two companies. The sponsor states that he is in a business and personal relationship with the applicant, but no evidence of either party having met previously has been provided. The sponsor states that he will give a personal undertaking. However, no details from the sponsor, apart from a personal bank statement have been given, identifying him, such as the bio date page of his passport. No evidence of any person from the Irish company travelling to the applicant's home country has been provided, and no evidence of where the business relationship began.</p>
