37371432	Refused	<p>CP:- Need to undertake the course in this State not demonstrated or warranted. The applicant previously studied English language in his country of origin, and no evidence has been submitted as to why he could not continue to study at home, rather than travel to Ireland.</p> <p>F:- Finances:- evidence provided is deemed insufficient or incomplete. The explanation given for the lump sum lodgement in the applicants bank account is not deemed credible.</p> <p>INCO:- Inconsistencies e.g. contradictions in the information supplied. As above, applicant states that there are no suitable courses available in his country of origin, however, then produces a certificate at appeal as evidence of undertaking an English language course. This is a direct contradiction.</p> <p>OB:- Obligations to return to home country have not been deemed sufficient. While a letter of employment was submitted at appeal, stating that the applicant has a job offer, valid for 24 months, once he improves his English language, the quality of this letter is not satisfactory - a mobile telephone number is used.</p> <p>OC:- Observe the conditions of the visa - the visa sought is for a specific purpose and duration:- the applicant has not satisfied the visa officer that such conditions would be observed.</p>

The applicant has not demonstrated evidence that there are no English language courses available in his country of origin, such that he needs to travel to Ireland to undertake one. Indeed, he has provided one letter stating that he is unacceptable for admission into higher education in his country of origin however, this one letter is not deemed sufficient evidence. The applicant has also provided an IELTS certificate, which shows that such testing is available in his country of origin.</p> <p>INCO:- Inconsistencies e.g. contradictions in the information supplied. Due to the uncertainty surrounding the applicants study plan, it is not clear what his intentions are should he complete his English language training - return to country of origin, or seek to continue studies in Ireland.</p> <p>OB:- Obligations to return to home country have not been deemed sufficient. See above. The applicant is not employed, nor has any concrete job offer in his country of origin.</p>
