#### **IRISH AID**

The Government of Ireland's official programme of assistance to developing countries, Irish Aid, is managed by the Department of Foreign Affairs and Trade (DFAT). The programme focuses on the fight against poverty and hunger in some of the world's least developed countries, particularly in sub-Saharan Africa. Ireland works in partnership with governments and communities in their attempts to alleviate poverty through helping them meet basic needs and through strengthening their capacity to help themselves.

#### IRISH AID FELLOWSHIP TRAINING PROGRAMME (IAFTP)

The IAFTP is part of Irish Aid's broad programme of support for capacity building by addressing capacity deficits that hinder the attainment of long-term development goals.

Applications are sought from organisations working in priority areas for the Irish Aid programme in-country as well as from individuals in organisations of strategic relevance to the work of the mission in that country. All applications are managed through the Embassy network.

Fellowships are generally targeted at mid-career professionals. Applications are accepted for study at master's degree level, in Ireland. Study at postgraduate diploma level may also be considered on an exceptional basis.

As part of the IAFTP, Irish Aid also offers a number of named fellowships: the Courtney fellowship for Burundi, the Casement fellowship in Nigeria, the Sean McBride fellowship in Namibia and the Frank Ferguson fellowship for Zambian engineering graduates. Each of these named fellowships has a separate application form. #### **IRISH COUNCIL FOR INTERNATIONAL STUDENTS**

The Irish Council for International Students (ICOS) – <a href="www.internationalstudents.ie">www.internationalstudents.ie</a> – provides support for the management and administration of the IAFTP. ICOS is an independent non-profit organisation that promotes best practice in relation to the recruitment, access and support of international students in Irish education.

# **ELIGIBILITY REQUIREMENTS**

To be eligible for the IAFTP, applicants must:

- be a citizen of one of the following countries: Cambodia, Eritrea, Ethiopia, Kenya, Laos, Lesotho, Liberia, Malawi, Mozambique, Myanmar, Palestine, Rwanda, Sierra Leone, Somalia, Sudan, Tanzania, Uganda, Vietnam, Zambia or Zimbabwe.
- be resident in that country.
- have achieved the necessary academic standard to be accepted onto a Master's degree course in a higher education institution in Ireland (an undergraduate degree at equivalent to pass level is not sufficient).
- be able to demonstrate a strong commitment to the development of their home country.
- have identified and selected two relevant courses from the Irish Aid Directory of Eligible Postgraduate Courses, available at <a href="https://www.irishaidfellowships.ie">www.irishaidfellowships.ie</a>.
- be applying to commence a new qualification and not be seeking funding for a course they have already commenced or which will begin before fellowship awards have been notified.
- be able to take up the fellowship in the academic year 2019/2020.

To be eligible for study in Ireland, applicants must be able to demonstrate their skills in academic English with an appropriate score on a recognised test (IELTS 6.5 or higher). See below for further information.

An applicant will not be considered further in either of the following circumstances:

- > They already hold a master's qualification.
- > They have applied for the IAFTP on two or more previous occasions without being awarded a fellowship. (Cases where an applicant withdrew from the process previously may be considered if there were exceptional or unforeseen circumstances for withdrawal in that instance).
- They are currently working, or it is anticipated that they will work in the future, at our embassies or at headquarters. Those personnel who have worked with any of our embassies/missions in the past must allow a full year before becoming eligible to apply for a fellowship.

In addition to the above, some additional eligibility requirements apply in some countries as follows:

Applications by invitation only	Cambodia, Kenya, Laos, Lesotho, Liberia, Malawi, Myanmar, Namibia, Palestine, Sierra Leone, Uganda, Vietnam, Zambia, Zimbabwe.
Minimum of 2 years' work experience following undergraduate studies	Cambodia, Ethiopia, Mozambique, Myanmar, Namibia, Uganda, Vietnam, Zambia.
IELTS certificate must be submitted at time of application (before November 30, 2018)	Ethiopia.

All successful applicants will be required to sign a commitment to return to their home country within 14 days of completing their studies in Ireland.

The closing date for receipt of applications to the Embassy of Ireland in participating countries is **30 November 2018**.

### **APPLICATION REQUIREMENTS**

Applications with unanswered questions or missing documentation will be deemed incomplete and <u>will not</u> be considered for a fellowship. Therefore, it is essential that you:

- fill out all required sections in this application form.
- include two recent passport-size photographs.
- include all relevant supporting documents and complete the checklist in Section 8.
- sign the application declaration in Section 9.

Your application will be photocopied. Pages should <u>NOT</u> be stapled together. Please do <u>not</u> use spiral or any other binding. Please print the completed application form in <u>single-sided format only</u>, and all accompanying documents must also be in single-sided format only.

# **SELECTION OF COURSE CHOICES**

You must select courses from the Irish Aid Directory of Eligible Postgraduate Courses available for download at <a href="https://www.irishaidfellowships.ie">www.irishaidfellowships.ie</a> with due regard to the courses being offered in your country. Some participating countries restrict the courses on offer to parts of the directory which are aligned with their priorities. Courses

should be listed according to first and second preference and are an important consideration in the review of applications.

You should ensure that you hold the specified qualifications and academic grades required for the academic courses you intend applying for. These can be found in the Irish Aid Directory of Eligible Postgraduate Courses and on the relevant college website. It is your responsibility to ensure that your academic qualifications are of sufficient standard for your chosen course.

Please choose your courses carefully. You will not normally be permitted to revise your choices after submission, unless a programme does not run. Applicants are therefore advised to thoroughly research their course choices. The relevance of the course to an applicant's career development and to the overall strategic priorities of the mission will form part of the assessment criteria.

Courses must begin no earlier than July 2019.

Note: Masters degrees by research are not eligible for the programme.

#### **SUBMITTING APPLICATIONS**

#### **SELECTION PROCESS**

#### Selection Round 1 / English Testing

The Embassy will conduct an *initial* shortlisting of applicants. **Unless the applicant already holds a valid IELTS test result (required in advance for candidates from Ethiopia),** applicants who meet the necessary criteria will be required to sit **an IELTS academic English test.** Tests are to be taken in January or February 2019. Arrangements, including payment of the test fee, will be organised by the Embassy of Ireland. (Applicants who already hold a suitable IELTS certificate should submit this with their application form).

**TIP:** You are advised to work through the practice materials at <a href="www.ielts.org">www.ielts.org</a> and attend a preparation session, if available. You should note that even people who regularly speak English can find the test a challenge. In a recent application year, approximately two-thirds of applicants tested did not get the necessary score to be considered further.

#### **Selection Round 2 / Course Applications**

The Fellowship Selection Committee will meet in Ireland in early April 2019 to conduct a second shortlisting round of those applications put forward by embassies. Those individuals who will be progressing as candidates will be contacted by ICOS with information on applying for their chosen college course(s). Application fees for colleges in Ireland will be paid by ICOS provided applications are made after notification from ICOS. Application fees paid prior to notification by ICOS will not be reimbursed. Applicants are advised not to apply for courses in Ireland until such time as they are notified by ICOS to proceed, when full application guidance will be provided. At that stage, the applicant will be responsible for ensuring that they submit their application to the college, including all relevant supporting documentation, and for keeping ICOS updated with the progress of their application. Applicants should note that decisions on Irish university course places may not be made by institutions until late June 2019.

# **Fellowship Awards**

A provisional list of awards will be drawn up in June 2019. Only candidates who successfully gain a course place and provide documentation to ICOS confirming this will be eligible for a fellowship award. **No candidate is guaranteed an award, even if all fellowship criteria are met.** 

If offered an Irish Aid fellowship, candidates will be required to:

- undergo a medical examination prior to confirmation of the fellowship award, and
- satisfy Irish immigration requirements.
