The quality of supporting documentation submitted by you in the following areas has diminished the overall credibility of your application;</p> <ul style="list-style-type: none"><li>• Documents provided by you to this office in relation to your parent's support of you financially. These documents are all copies and as previously indicated original documents must be provided.</li></ul> <p>3. The visa officer has examined the evidence submitted by you in support of your application and has found no credible reason for the proposed trip. The following information has been considered as part of this decision;</p> <ul style="list-style-type: none"><li>• Your proposed field of study – it does not seem credible that you would choose to study English in Ireland, rather than study same part time in UK. The financial documentation submitted in support of this visa application has not been deemed sufficient.</p> <p>2. A portion of the money available to you for this trip has been lodged to your account in lump sums within the past 90 days, and no explanation as to the source of this money has been provided.</p> <p>3. You have not provided any evidence as to the source of your income.</p>

Information available to the visa office indicates that you have negative immigration history which you have failed to declare on your application form.</p> <ul style="list-style-type: none"><li>• Applicant was illegally in Ireland and failed to declare this in initial application. Applicant has admitted to this in their appeal letter and stated they were unaware that a visa was required. Applicant has visas from several other countries and as such the appeals officer is not satisfied that the applicant was ignorant of his immigration obligations. Applicant is therefore not permitted to make further visa applications for a period of five years. Any application made by the applicant before this time has elapsed will be refused.</li></ul> <p>C - OB/OC</p> <p>1. Information available to the appeals officer concerning your immigration history has diminished the overall credibility of your application. The appeals officer has considered the evidence of ties to your country of ordinary residence submitted, however this has not been sufficient to satisfy the appeals officer, on the balance of probabilities that you are likely to observe the conditions of any visa granted.</p> <p>2. The visa sought is for a specific purpose and duration: the applicant has not satisfied the appeals officer that such conditions would be observed. The appeals officer is not satisfied that the sole purpose of your intended travel to Ireland is genuine tourism. As such, the appeals officer is not satisfied that you will observe the conditions of any visa granted.</p>

The failure to submit sufficient supporting documentation in the following areas has diminished the overall credibility of your application;</p> <ul style="list-style-type: none"><li>• It is noted that you provided a report showing the loss of a passport. However, you have still provided no further evidence on your immigration or travel history in the UK. You have failed to provide any evidence showing how you first entered the UK.</li></ul> <p>2. The quality of supporting documentation submitted by you in the following areas has diminished the overall credibility of your application;</p> <ul style="list-style-type: none"><li>• Financial documents</li><li>• Employment documents</li><li>• Link to reference – other that stating reference is a friend of husband, no further evidence to show why multiple journey visa is required.</li></ul> <p>3. The appeals officer has examined the evidence submitted by you in support of your application and has found no credible reason for the proposed trip. The following information has been considered as part of this decision;</p> <ul style="list-style-type: none"><li>• Your family circumstances</li><li>• Your employment details</li><li>• Your travel history</li></ul> <p>B - Finances</p> <p>1. The financial documentation submitted in support of this visa application has not been deemed sufficient.</p> <p>2. The majority of the money available to you for this trip has been lodged to your account in lump sums within the past 90 days, and no explanation as to the source of this money has been provided. There are numerous deposits from Contis Card Solutions, these make up a large portion of your deposits into your account. You have said these came from your husband but have provided no evidence of this and the accounts you have provided in your appeal do not correlate with the Contis Card transfers.</p> <p>3. You have not provided any evidence as to the source of your some of your income.</p> <p>C - OB/OC</p> <p>1. Information supplied by you concerning your personal, economic and family circumstances has been insufficient to satisfy the appeals officer that you would observe the conditions of any visa granted, with particular regard to the use of public funds and public resources.</p> <p>2. Information available to the appeals office concerning your UK immigration history, along with your personal, economic and family circumstances, has diminished the overall credibility of your application. As such, the appeals officer is not satisfied that you will observe the conditions of any visa granted, with particular regard to the maintenance of the integrity of the Common Travel Area.</p>
