Information available to the Visa office would suggest that you are married and that your spouse has also applied to undertake the same course at Dublin Business School, as well as also having sought to rely on the same loan from Andhra Bank as a means to demonstrate financial capacity to undertake a course of study in Ireland. This is a clear attempt to circumvent the immigration process on the part of the applicant.</li> <li>F: - Finances: - the Visa Officer has examined and considered all the financial evidence submitted, and is not satisfied that you are in a financially adequate position to support your complete period of study in Ireland. The visa officer is not satisfied that you have access to the finances required to pay for the course and support yourself during your stay in Ireland, as required. In this regard, it is noted that both the applicant and his wife have stated their intent to rely on the same loan amount over the course of separate periods of study. This is clearly an attempt on the part of the applicant to misrepresent their financial status with a view to obtaining a visa by deception.</li> </ul>
