No evidence of communication with the relevant immigration authorities has been submitted. Your solicitor submits you returned to India on 2nd March 2016 however no evidence of same has been submitted. The visa officer cannot verify your return date due to aforementioned damage to your passport.</p> <p>INCO:- Inconsistencies e.g. contradictions in the information supplied</p> <p>It is stated that the applicant and sponsor travelled to Ireland from the UK on an unspecified date following 28th April 2015.
